YD Junior Member Policy:

Age limits are also subject to local, state, and federal laws.

The following rules pertain to age limits and participation at events:

1. Any person over the age of 16 but under the age of 18 may apply to become a Junior Unit Member, or he/she can be part of a family membership. A Junior Unit Member must submit a signature of consent and release of liability from a parent or legal guardian.
2. 16-17 year-old members can participate in the field in battle re-enactments without supervision and can carry arms, same as adults.
3. Members under 16 years old can participate in the field as non-combatants at the discretion of the Unit Commander or senior commissioned officer present. They may not carry firearms in the field, nor firearm-related equipment. Examples of non-combatants are medics and radiomen, examples of firearm-related equipment are holsters and cartridge belts.
4. Parents of members under 16 years old are responsible for the child's good conduct and safety. A Parent must be present with an under-16 child at any events the child attends. Parent must attend as a member, participating in the event, in uniform, and in the vicinity. In operations in the field, the Parent must be at the child's side.
5. If an event's rules, or any part of them, are stricter than these rules or any part of them, then those stricter rules or parts shall govern.
6. As used in these rules, "parent" can be parent, legal guardian, or a person designated to act as parent, in writing, signed and dated by the parent or guardian.
7. All junior members under the age of 18 need to have the YD Child's Release & Hold Harmless Agreement signed and co-signed by a parent or guardian.
